- President's Report

A warm welcome to all attendees of our 2024 AGM. It's great to see familiar faces and new members alike gathered here today.

Updates Since Last Meeting:
Since our last meeting, the wheels of our P\&C association have been turning, and I'm excited to share the progress we've made:
a. Sunset Picnic Snack Bar: Our recent sunset picnic was not only a delightful community event but also a successful fundraising opportunity. Hayley and I managed to generate $\$ 276$ which enabled us to break even on stock purchased. With leftover stock, we're now creating Mother's Day chocolate hampers. I will need help assembling these hampers and making them look pretty.
b. Weekly Subway Lunches: In response to the closure of the canteen, we've explored partnerships with Subway to offer weekly lunch options for our students and families. While this initiative aims to provide a convenient alternative, it's worth noting that recent price increases have limited our
fundraising capacity in this area. Nonetheless, I believe it fills a gap particularly for time poor families. I'm in the process of setting it up on spriggy and was hoping to get an order in before the end of this term but I think now we will start next term.
c. Voluntary Contributions: Despite our efforts to promote voluntary contributions, responses have been modest. Nevertheless, I'm immensely grateful for the $\$ 2.5 \mathrm{k}$ we've raised thus far. It's a testament to the generosity of our school community, especially considering the financial strain many families are facing.
d. Hot Cross Bun Drive: Our exploration into the feasibility of a hot cross bun drive unfortunately hit a roadblock due to pricing constraints from potential suppliers. As a result, we've decided to shelve this idea for the time being.
e. Mother's Day Gift Shop: We've sourced stock for our upcoming Mother's Day gift shop from a new supplier in Joondalup. Not only does this supplier offer superior quality items, but we've also managed to save on postage costs by arranging for in-person pickup. I've not been able to get there yet so if anyone is able to assist with collecting the stock, please let me know.
f. Mother's Day Raffle: I've secured a gourmet gift hamper from our local Labour Member David Michaels. My plan is to use this as the prize for our Mother's Day Raffle so I'm just waiting on delivery to photograph it and get the flyers out. I will need some help with the flyers.
g. Support for Year 6 Fundraiser: In the spirit of community support, we've donated our leftover Zooper Doopers to the Year 6 icy pole fundraiser, lending a helping hand to their leaver shirts fundraising efforts.
h. P\&C School Board Rep: I'm delighted to share that I've accepted the role of P\&C representative on the School Board. This presents an exciting opportunity for closer collaboration and alignment between our two entities, ensuring the best outcomes for our school community.
i. Term 2 Initiatives: Looking ahead to the next term, we have a host of exciting initiatives lined up, including the Mother's Day Gift Shop and raffle, book fair, subway lunches, and Hoyts movie passes. Stay tuned for more details as these events unfold.
j. Sunset Picnic Challenge: While our recent sunset picnic was a success, we did encounter a challenge with the Tyro card payments device. An update communication issued in December last year unfortunately did not reach us, resulting in a device malfunction. We're currently exploring options to rectify this issue, including potentially transitioning to Square for its enhanced functionality and convenience for $\mathrm{P} \& \mathrm{C}$ associations.
k. Thank You to Hayley: A heartfelt thank you is in order for Hayley, our stand-in secretary, who has generously lent her time and expertise to sort out the admin of the P\&C. Hayley's contributions have enabled me to focus more on our fundraising efforts, and for that, I'm immensely grateful.

m. Volunteer Callout: As always, we need volunteers to help us run our fundraisers and organise everything. ## Welcome to our P\&C AGM

It is a pleasure to have you all here.

This term has nearly finished, and the school has been running smoothly despite several challenges. We have had to face the excessive heat and the Department of Education ensured that all schools had a heat policy implemented, which we have done.

What this means is that the weather is monitored and when extreme heat is called the following happens:

- Students have water bottles inside

The state government has announced that they will be providing all families with a one-off payment of $\$ 150$, this is not an automatic payment, families need to apply through the service WA app, not the school. To do so, all families will need their individual child's WA school number, which can be found on the NAPLAN and school reports, we will be providing this information to all families as well as some more information on how to make the claim.

I would like to thank everybody for their attendance, support, and care. The school community is an extraordinary one and I am grateful to be back next term.
