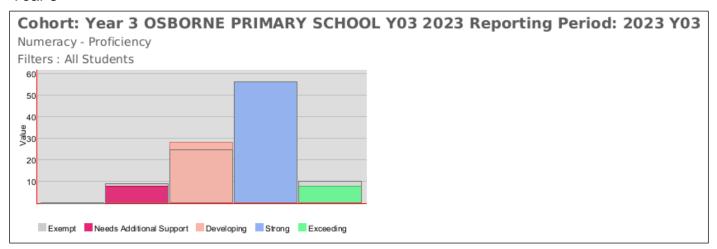

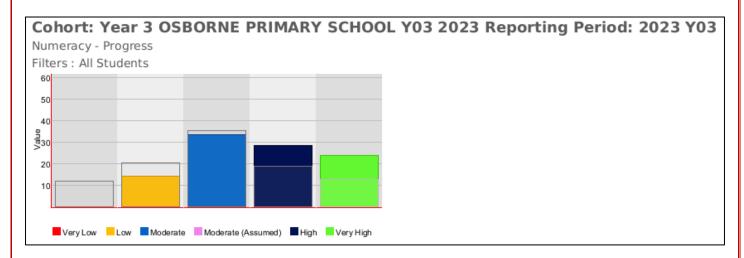
NAPLAN

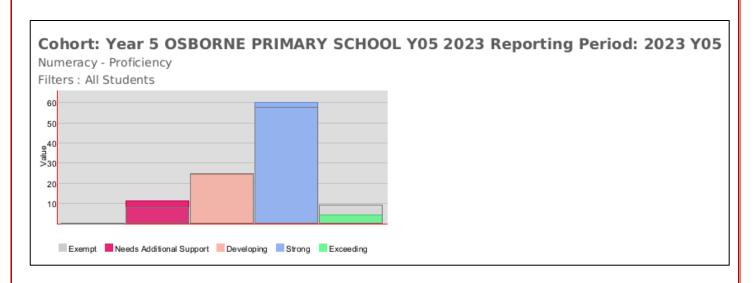

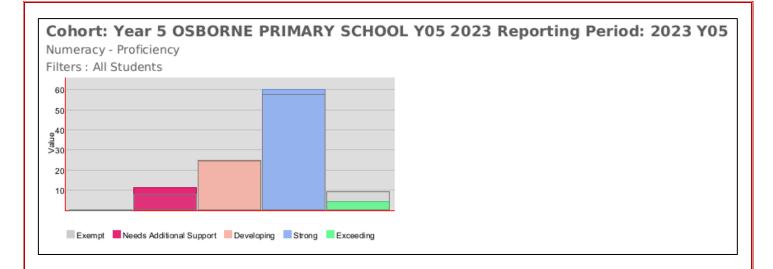




Results demonstrate that students are achieving good results in NAPLAN.

Year 5



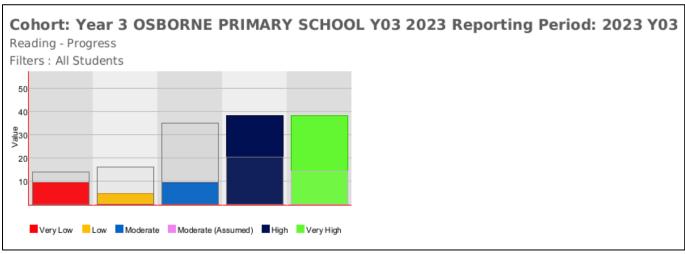


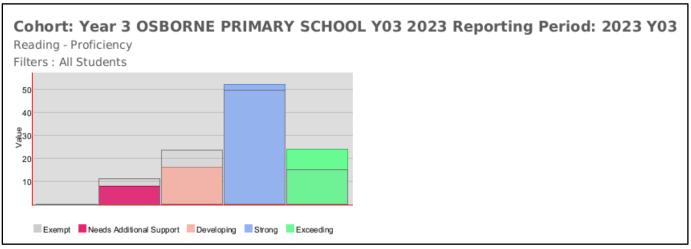
